### 14 June 2023

# IV. Remarks from Todd McCaffrey, Secretary, SCDVA:

- A. Has been on the job for three months has been a quick 90 days
- B. Thanked all Board members for their service to the Veterans' Trust Fund
- C. SCDVA's mission has not changed:
  - i. Assist Veterans and County Veterans Affairs Officers
  - ii. Advocacy role in supporting military
  - iii. Inform Veterans and others about matters
  - iv. Integrating all entities in South Carolina regarding Veteran related issues, linking them together
- D. SCDVA is now 48 individuals strong
- E. Networks function on three arms: resource integration coupling
- F. Veterans' Trust Fund
  - i. Recent restructuring changed the board from 19 to 11 members
  - ii. The Executive Director is now a non-voting member
  - iii. The Governor's Office will determine who is on the board, making it more cohesive
  - iv. Anything the Veterans' Trust Fund can do to generate funds is beneficial
- G. Discussion regarding fundraising:
  - i. Veteran Golf Tournament with proceeds going to the Veterans' Trust Fund
  - ii. Lt Col Singleton offered to hold a bird shoot on his farm

    - o Handed out notes from their May meeting
    - Need to craft out a message, create branding, start marketing/campaigning with television stations and community events
    - Could partner with other groups, like DAR, for advertising
    - Ms. Stewart will put something strong together that everyone can use
  - Long-Range Planning Committee, Dr. Wooten:
    - Need to streamline grant proposal, designate priorities, and have deadlines for grants
    - Create a webinar to assist people
    - Create a grant review committee to deem who is feasible, and invite only those who meet priority criteria
    - Need to create an Executive Summary or Abstract about the Veterans' Trust Fund

Chairman Ellenburg reminded members to be respectful of co-members by not sharing their information.
